PLEASE READ CAREFULLY BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.

TO: The Outward Bound Trust of Hong Kong Limited, it's officers, directors, employees, agents, representatives (all of whom are collectively referred to as "Outward Bound® Hong Kong")

I AM AWARE that my participation on any trip or course with Outward Bound® Hong Kong involves exposure to many RISKS, DANGERS and HAZARDS which may be greater or different than those I normally encounter. Such RISKS, DANGERS and HAZARDS include but are not limited to:

- a. travel and survival in the wilderness;
- b. inadequate physical fitness or endurance;
- c. the use and operation of vehicles, vessels and equipment;
- d. the use of defective equipment;
- e. changing weather conditions;
- f. varying environmental conditions;
- g. varying wilderness conditions;
- h. encounters with and attacks by wild animals;
- i. negligence on the part of Outward Bound® Hong Kong;
- j. negligence on the part of fellow participants on the trip.

I AM FURTHER AWARE THAT I may be exposed to RISKS, DANGERS, and HAZARDS other than those listed above.

I FREELY ACCEPT AND FULLY ASSUME all and any such RISKS, DANGERS and HAZARDS and the possibility of PERSONAL INJURY, DEATH, PROPERTY DAMAGE or LOSS resulting from such RISKS, DANGERS, and HAZARDS.

I AGREE TO COMPLY WITH THE DIRECTIONS and INSTRUCTIONS of Outward Bound® Hong Kong before and throughout the trip/course.

I AGREE to allow Outward Bound® Hong Kong to use any and all images and/or testimonials taken of or provided by me during the trip/course for any and all marketing purposes.

IN CONSIDERATION of Outward Bound® Hong Kong accepting my application and permitting my participation on the trip/course, I HEREBY AGREE as follows:

1. TO ASSUME AND ACCEPT ALL AND ANY RISKS, DANGERS and HAZARDS arising out of, incidental to, or in any way connected with my participation on the trip/course;
2. TO WAIVE ANY AND ALL CLAIMS, ACTIONS, COSTS, EXPENSES AND DEMANDS that I may have against Outward Bound® Hong Kong;
3. TO RELEASE Outward Bound® Hong Kong from any and all liability for any LOSS, DAMAGE, INJURY, or EXPENSE that I, or my next of kin, may suffer or incur as a result of my participation on the trip/course, due to any cause whatsoever, including negligence on the part of Outward Bound® Hong Kong;

4. TO OBEY ALL DIRECTIONS AND INSTRUCTIONS from Outward Bound® Hong Kong before and throughout the trip/course;
5. THAT MY LEVEL OF PHYSICAL FITNESS AND ENDURANCE IS ADEQUATE for my participation on the trip/course;
6. THAT I HAVE TO THE BEST OF MY KNOWLEDGE, COMPLETED the Outward Bound® Hong Kong Confidential Medical History Form and that Outward Bound® Hong Kong will rely upon the medical information disclosed therein;
7. If I deem it necessary, TO VERIFY WITH MY PHYSICIAN to ensure that I do not have any physical or psychological problems which would create undue risk to myself or fellow participants on the trip/course;
8. THAT THIS RELEASE AND INDEMNITY AGREEMENT SHALL BE EFFECTIVE AND BINDING upon my heirs, next of kin, executors, administrators, and assigns, in the event of my death.
9. I AGREE THAT THE LAWS OF HONG KONG govern this contract and that any legal concerns will be handled in the competent and fair courts in Hong Kong.
